1. EXECUTIVE DIRECTOR REPORT

- Update was provided to Board on shared Google drive folder
- Highlights/key points shared:
 - Planning underway for 2025: BW series in Brandywine; approximately 75 hectares in R10 blocks along Callaghan Creek FSR in past wildfire risk reduction projects
 - CCF & CRGL staff working with Canadian Wilderness management to understand where areas of concern are and minimize impacts
 - Discussion market impacts of Softwood Lumber dispute with US will likely result in <u>increased duties in August</u>. Uncertain impacts to the BC markets. Note that CCF wood is not competing in hard, competitive markets and we may experience steady prices with solid demand.
 - Climate Resiliency Planning Frontera completed the risk assessment. Chartwell beginning work on the operational plan later this summer. Aim is to get 2026 harvesting referrals submitted before year end in order to be ready for 2026 harvesting.
 - Western Spruce Budworm Engagement with all Coast Nations including Lil'wat Nation and Squamish Nation underway. Public engagement will follow. Provincial WSB team coming to Spel'kumtn CF on July 2.
 - Jordon noted that he is touring the Lil'wat Nation rights and title team in CCF soon and requested copy of risk assessment.
 - MacLaurin Memorial Scholarship first scholarship was awarded to Nate Lawrence of Whistler Secondary School. CCF Board discussed that scholarship information didn't seem to get passed to Lil'wat and Squamish Nations before Whistler Community Foundation (WCF) application deadline passed. Board wishes to award 3 scholarships each year, one for each partner community. The Whistler Secondary award will still go through Whistler Community Foundation while CCF ED will distribute annual application paperwork directly to Squamish and Lil'wat Nations' educational reps and CCF Board will choose the successful applicants. CCF annual budget will cover the costs of the Lil'wat and Squamish Nation scholarships while the WCF fund will cover the Whistler scholarship. If there are no suitable applicants from a partner community, the funds will be retained in the CCF account.

Moved by M. Pardoe Seconded by A. DeJong

That the Cheakamus Community Forest Board of Directors amend the scholarship award program to allow for one annual scholarship to be awarded to suitable applicants from each of the CCF partner communities.

 RMOW Trails Strategy passed by Council recently. It is a high level decisionmaking policy rather than a location based trail alignment plan.

2. CARBON SALES

- Woodfibre LNG made a request to CCF Board to consider a one time top up for construction phase offsets, plus an operational phase five year procurement with options to renew.
- Board discussed the proposal. Noted that WLNG is local, making significant efforts to carbon reduced operations, contributes to the local economy and the Squamish Nation is a beneficiary and a regulator of the project. Board directed negotiations to seek best prices and terms for both the construction and operations phases and leave option for sales prices to increase in future. Board wishes to hold some credits back for other buyers.
- Other potential compliance purchasers are approaching CCF. Board requests that ED and Robert Seaton hold meetings then report back to Board for discussion as per CCF carbon purchasing policy.

3. 2024 FINANCIALS

Board reviewed the 2024 financials provided by BDO. No further discussion.

4. NEW BUSINESS

 Molly Hudson thanked the Board for supporting her nomination to the BC Community Forest Association Board.
